Annexure - I

Terms & Condition for Supply of Coal

1. Weight of Coal will be considered only as per our weighbridge
2. Sample of every load shall be collected & checked by us and the result of which is final and binding on both supplier & purchaser.
3. The supplier has to provide analyses test report of goods along with the each load, as well as our technical team shall test the material at our site
4. If supplied material is not as per our specification shall be rejected full load or if impurities (stone, excess moisture or any other impurities) are slightly higher than our specification then rejection shall be made on pro-rata basis.
5. Payment will be made after supply of total quantity.

6. **Penalty:**

Penalty will be levied on the landed value of coal cost on pro – rata basis.

Gross Calorific Value (GCV)

- a) If the GCV of coal goes below **4100 Kcal/kg** then PMT Rs. 500/- penalty will be levied, however it will be informed to you before unloading the truck.
- b) If the GCV Goes below **3700Kcal/kg** then full load will be rejected.

Size of coal (Sieve Size)

- a) **Complete Screened Coal, 35 mm to 100 mm & Zero % Dust. Above Size of 100mm coal not accepted**

Moisture

- a) If moisture percentage goes above 10% then full load will be rejected

Fine Particle

- a) If fine particle percentage goes above 10-20% then 10% penalty will be levied.
- b) If fine particle percentage goes above 20% then full load will be rejected
